



GUEST SPEAKER



AMBASSADOR MANPREET VOHRA

High Commissioner of India to Australia.

Ambassador Vohra joined the Indian Foreign Service in 1988. He was Ambassador of India to Mexico and High Commissioner to Belize (2019-21), Ambassador to Afghanistan (2016-18) and Ambassador to Peru and Bolivia (2011-15).

Earlier, he was Deputy High Commissioner in Pakistan (2007-09) and in Nairobi (2005-07) where he was also Deputy Permanent Representative of India to the United Nations Environment Programme and UN-Habitat. Prior to this, he served in various capacities at the Indian Missions in Hong Kong, China, Mongolia and United Kingdom.

At the Ministry of External Affairs in New Delhi, Ambassador Vohra was Additional Secretary (Administration; Consular, Passport, Visas; and Counter-Terrorism) during 2018-19, Joint Secretary (Development Partnership Administration-I) during 2015-16, and Deputy Secretary and Director (Disarmament & International Security Affairs) during 2000-02. From 2009-11, he was Joint Secretary & Officer on Special Duty in the Project Office to set up the South Asian University in New Delhi.

Ambassador Vohra holds a BA in Economics and a Post-Graduate Diploma in International Trade from Panjab University, Chandigarh. He was a Chevening Scholar at Oxford University in 1999-2000 where he obtained a Certificate in Diplomatic Studies.

GRAND FINAL JUDGES AND MEDIATOR



THE HON. ROBERT FRENCH AC

Patron, Australian Disputes Centre

Robert Shenton French AC served as the twelfth Chief Justice of Australia from 2008 to 2017. Mr French was born in Perth, Western Australia and was admitted as a barrister and solicitor in 1972. He was appointed to the Federal Court in 1986, serving as a justice on that court until his elevation to the High Court on 1 September 2008. In July 2008, Prime Minister Kevin Rudd named Mr French as Chief Justice, becoming the first Chief Justice from Western Australia.

Mr French has held a long standing interest in ADR processes. As a Judge of the Federal Court Justice French was passionate about the use of court-annexed mediation as a way of encouraging more, and earlier settlements or at least narrowing the issues in dispute. He was also interested in the use of serving judges as mediators in Court Proceedings on the basis that a mediating judge would not have anything to do with hearing the case if mediation did not effect a settlement. It was these key areas of interest that drew him to his patronage of the Australia Disputes Centre in late 2017. Since that time, Mr French has been keenly involved in the important work of the ADC in advancing the uptake and best-practice of ADR.



PROFESSOR NOHYOUNG PARK

Professor of Law, Korea University Law School

Nohyoung Park is a professor of law at Korea University Law School since September 1990. His original specialty is international economic law focusing on the WTO, but he has also been studying cybersecurity and data privacy, and negotiation and mediation. He has advised governments and businesses on various international legal matters, including by participating in the negotiation of the Korea-Chile free trade agreement, Korean first FTA, and by attending the meetings of the 4th and 5th UNGGEGs in information security between 2014 and 2017. He graduated from College of Law, Korea University (LL.B., 1981), Graduate School, Korea University (LL.M., 1983), Harvard Law School (LL.M., 1985), and University of Cambridge (Ph.D. in International Law, 1990). He was awarded the honorary doctoral degree in law by the Far Eastern Federal University in Vladivostok, Russia in October 2018.

JAWAD A. SARWANA

Partner and Advocate Supreme Court

Jawad A. Sarwana, Partner at Abraham & Sarwana and Advocate of the Supreme Court, Pakistan earned his undergraduate degree from the USA and his professional law degree from the University of Buckingham, England. Jawad mediates commercial and corporate disputes in Pakistan, including family-run business disputes, intellectual property disputes (trademarks), international trade (textile sector); financial facilities (credit lines involving small-medium enterprises) and shareholder disputes.

He is one of the founding members of Pakistan Mediators Association PMA and an international commercial negotiation and mediation trainer. In 2018, his mediation role-play “Kohinoor” won the First Prize at the ICC International Mediation Competition, in Paris and he has maintained his close connection as a judge, supporting both the Asia Pacific and ICC International Commercial Mediation Competitions.

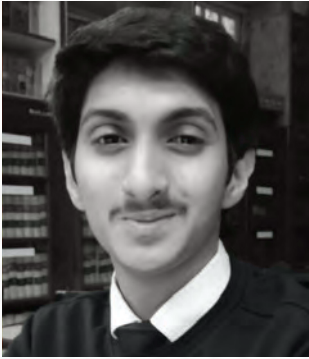


MALLIKA S. LUTHRA

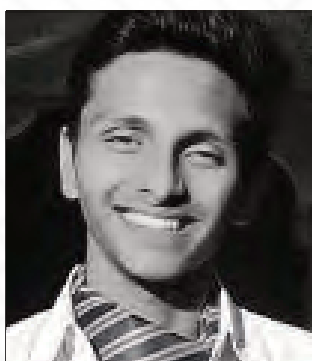
SAMYUKTHA KARTHIKEYAN
