PETER McMULLIN AM

Chairman, Good Business Foundation and President of the Confederation of Asia-Pacific Chambers of Commerce and Industry (CACCI)

Peter McMullin AM has an extensive legal and business career encompassing prominent roles in both the public and private sectors.

In business Peter is the Chairman and Director of McMullin. A diversified family business based in Melbourne. Australia, Peter is also President of the Confederation of Asia-Pacific Chambers of Commerce and Industry (CACCI) spanning 26 countries in the region with offices in Melbourne, Singapore and Taipei. In 2019 Peter established the Good Business Foundation (GBF) which focuses on supporting inclusive and sustainable small and medium sized businesses in the Asia-Pacific region. In 2022 he was appointed by the President of Timor-Leste, Jose Ramos-Horta to the position of Presidential Envoy - Private Sector and Investment Co-operation for Timor-Leste.

In his legal work Peter is Special Counsel for Cornwalls, specialising in improving outcomes for the firm and its clients by facilitating meaningful connections between like-minded people in the area of business, politics, philanthropy and the arts within Melbourne and throughout Australia.

In his representative and governance roles Peter holds Board positions with WorkSafe Victoria and the Melbourne Recital Centre. He is also the Honorary Consul of Georgia in Victoria and former Honorary Consul for Timor-Leste in Victoria.

As an active philanthropist, Peter seeks to collaborate with other individuals and organisations to maximise the impact of his contributions. Examples include supporting the establishment of the world's first academic Centre dedicated to the issue of Statelessness at Melbourne University Law School as well as the establishment of the Science Gallery Melbourne.

If we trade and do business with each other in a respectful and mutually beneficial way then we will be less likely to enter into conflict with each other. GRAND FINAL JUDGES AND MEDIATOR



THE HONOURABLE HELEN MURRELL SC Lawyer, Former Chief Justice of the Supreme Court of the Australian Capital Territory.

The Honourable Helen Murrell SC, former Chief Justice of the Supreme Court of the ACT, is the first woman to be appointed Chief Justice. She retired in March 2022 and has since been appointed as one of the Commissioners of the New South Wales Independent Commission Against Corruption (ICAC).

Her Honour was admitted as a solicitor to the Supreme Court of New South Wales in 1977. From 1977 to 1981 her Honour practised at the Commonwealth Crown Solicitor's Office and NSW Legal Aid Commission. In 1981 to 1996 her Honour practised as a Barrister and practised criminal law, administrative law, environmental law, common law and equity. From 1994 to 1996 her Honour was the first Environmental Counsel for the NSW Environment Protection Authority. In 1995 her Honour was appointed Senior Counsel in New South Wales. From 1996 to 2013 her Honour was appointed as a Judge of the District Court of New South Wales. In 1996 her Honour was also an Acting Judge in the Land and Environment Court of New South Wales. From 1997 to 1999 her Honour was President of the Equal Opportunity Tribunal of New South Wales. At the same time her Honour was Deputy President of the Administrative Decisions Tribunal of New South Wales, Head of the Equal Opportunity Division. From 1998 to 2003 her Honour was the first Senior Judge of the Drug Court of New South Wales. In 1999 her Honour was a member of the United Nations Expert Working Group on Drug Courts, Vienna. From 2005 to 2013 her Honour was Deputy Chairperson of the New South Wales Medical Tribunal.



PROF. DR. FRANCIS LAW President of HKMC, Chairman of IDRRMI, President of AIDRN

Dr. Francis Law is an experienced international business consultant and expert of dispute resolution. He has more than 29 years of experience in Public Administration Management, Human Resources, Conflict Management and corporate development.

Dr. Law has conducted a wide variety of mediation cases. He is currently serving on a number of Panels of renowned International Mediation and Arbitration organizations in Hong Kong, China, Macau, Thailand, Vienna and Spain. He is an Annexed Mediator and Professional juror of the People's Court of Qinghai, China. Since 2012, he has been appointed by the Movement of Hong Kong as the member of the Steering Committee on Mediation, and its cub-committee.

Dr. Law was conferred with the title of Honorary Doctorate in Law and holds a Master Degree in Business Administration. He is the Lead Trainer and the Lead Assessor of the DR profession in Hong Kong, Macau, Thailand, Bangladesh, Shenzhen, Qinghai, Guangzhou and Beijing. He is the Adjunct Senior Lecturer of the Law School of Macau University of Science and Technology and City University of Macau. He has trained up hundreds of International Mediation coaches, assessors, trainers and related professionals ion to dispute resolution in Hong Kong, the mainland and overseas.

GRAND FINAL JUDGES AND MEDIATOR



RAJESH SHARMA

Senior Lecturer, Panel Arbitrator, KCAB. Member, Centre for Global Research

Dr. Rajesh Sharma is currently teaching at RMIT University, Melbourne, Australia. Before coming to Australia, he was Assistant Professor at School of Law, City University of Hong

Dr. Sharma has given training and taught courses on arbitration, mediation, negotiation, foreign investment arbitration, WTO Law, international trade, banking law, foreign investment in Hong Kong, Macao, India, Australia, China, Myanmar, Thailand, Vietnam, Indonesia, Malaysia, Singapore, Papua New Guinea, Nepal, Mauritius, and Africa (where he is associated with the African Centre for Legal Excellence in Uganda). He has served as the Legal Advisor to the Macau University of Science and Technology. He has advised transnational companies on trade and investment policy in China and has done training courses with and for the WTO and UNITAR. Dr. Sharma is the Winner of the ADR Teacher Award 2023 in Australia.

Dr. Sharma is the first Indian to hold PhD in Law from China. He holds PhD from the Chinese University of Political Science and Law, Beijing, a Master of Business Law from Monash University, Australia, an M.Phil from City University of Hong Kong and the Bachelor of Laws from the University of Delhi. He has received training for arbitrators from the World Intellectual Property Organization (WIPO), Geneva; and International Chamber of Commerce and Chartered Institute of Arbitrators. Dr. Sharma has received training of a mediator for community conflict resolution by the Plowshares Institute, USA and the Accord Group of Australia. He has also obtained professional training in negotiation at Harvard Law School. He has received training for teachers of WTO organized by UNU-IAS.



MARY WALKER OAM

Barrister and Australia Mediator of the Year 2016, 2017 & 2018

In a career spanning nearly three decades, Mary has truly been at the forefront of ADR practice at the Bar, having mediated thousands of matters in a wide range of dispute-types and jurisdictions, from Supreme Court of NSW to the Singapore International Mediation Centre Panel. Her practice includes an extensive list of complex domestic and cross-border disputes in all areas of civil law. Her expert appraisal and Ombudsman services are highly sought-after, having also been appointed by the Federal and NSW State Governments to carry out inquiries into Aboriginal heritage listings. Mary is Chair and Member of multiple Boards and ADR related Committees.

In addition to her distinguished practice achievements, Mary's teaching work and publications have contributed substantially to the promotion and advancement of ADR. She has lectured on the topic at various prestigious institutions, including Harvard, Stanford, and Sydney University, and is a current member of the Faculty of Law at the University of Technology, Sydney. Mary has written extensively, including the book chapter Expert Determination in the renowned The Laws of Australia and 'No Mere Mouthpiece' in the NSW Bar Association Centenary Essays.

For her exceptional practice and service in ADR, she was awarded for "Outstanding Contribution to Australian Dispute Resolution" in 2017 by the Australian Dispute Resolution Association. In 2021, Mary was awarded a Medal of the Order of Australia (OAM) for her service to the law.

BRONWYN LINCOLN

Partner Thomson Geer Lawyers, Director, Australian Disputes Centre

Bronwyn is a Director of the Australian Dipsutes Centre and is a Partner in the Disputes team at Thomson Geer with extensive experience in commercial litigation and international arbitration.

She also regularly advises on conflicts of laws, international treaty rights and obligations (including the CISG) and on the enforcement of foreign judgments and foreign arbitral awards in the Australian courts.

Bronwyn's practice covers a range of industry sectors, including international trade, insurance, building and construction, energy and resources, pharmaceuticals, technology and renewables. She has a particular interest in the resolution of joint venture and shareholder disputes and a specialist practice in cross border and multijurisdictional matters.

Bronwyn has acted for national and international clients in high value disputes in most of the superior courts in Australia and has experience in the conduct of arbitration under the rules of many of the world's leading arbitral institutions, including the Singapore International Arbitration Centre and the International Chamber of Commerce, and under the UNCITAL Arbitration Rules. Bronwyn also sits as an international arbitrator, both as sole arbitrator and presiding arbitrator.

Amongst other roles, she is a director of ACICA and the Australian Disputes Centre, vice-chair of the Federal Litigation and Dispute Resolution Exec of the LCA, a member of the ICC Commission on Arbitration and ADR and one of Australia's four designated conciliators for ICSID (World Bank).

Having practised as a litigation lawyer before turning full time to mediation, Alan has over 30 years of experience mediating commercial and intellectual property disputes of all kinds in Australia, New Zealand and the UK, in which parties are legally represented. He was described by Who's Who Legal: Mediation 2018 as "one of the best mediators in the world" and by Who's Who Legal: Australia 2019 as one of the three "Most Highly Regarded" mediators "for their expertise in handling sophisticated disputes across a wide range of industries" and in 2021 as one of the Asia Pacific Global Elite Thought Leaders in Mediation.

Alan Limbury is a pioneer of mediation in Australia. He established the first ADR practice group in an Australian law firm and was a Founder and former Chairman of LEADR (now Resolution Institute). He contributed to the adoption by the Law Society of NSW of a model contract clause for the resolution of disputes and guidelines for solicitors who practise as mediators and to the Law Council of Australia's policy on ADR, model legislation and rules for court-annexed mediation, ethical standards for mediators and the role and responsibilities of lawyers in mediation.

Alan has mediated over 3,000 commercial and intellectual property disputes in Australia, New Zealand and the UK, in which parties are legally represented.




KWANSEI GAKUIN UNIVERSITY JAPAN

TANG HSUAN JUNG






MAHARASHTRA NATIONAL LAW UNIVERSITY MUMBAI, INDIA






SOPHIA RICHARDS
